We are pleased to inform you that our company as of November 9<sup>th</sup>, 2019 will commence deliveries of the new Very Low Sulphur Fuel Oil 0, 50% both in Crete, Kali Limenes anchorage and in Piraeus anchorage.

In order to safeguard excellent quality and avoid contamination of the new product we have allocated in our installation in Crete, specific tanks to receive and store the new product. Further to this we have dedicated specific bunker barge for the deliveries of the new product and the pipelines as well as the tanks that will be used, have been properly cleaned.

In Piraeus the product will be received directly from the refinery and delivered to the receiving vessels without any physical storage taking place.

The new product bears the following typical specifications:
